BALIKBAYAN UNDER RA 6768

Only nationals from non-visa required countries under EO 408, Former Filipino or traveling with the Filipino/former Filipino spouse/parent

FOREIGN NATIONALS WITH VALID AND EXISTING VISAS

9(a) visa holders are required an entry exemption document** from the country's foreign posts abroad]

*Except those coming, or with a travel history within the last 14 days, from countries not allowed to enter the Philippines. Subject to the presentation of required supporting documents. Please see www.immigration.gov.ph for further details

** Except foreign spouses, parent/s, and/or children of Filipino citizens, not traveling together with the Filipino. Shall present a visa with the notation "EED not required per IATF Resolution No. 128 (s.2021)"

Except for transiting passengers and Filipinos who are part of government or non-government repatriation efforts

TO BE PRESENTED BY TRAVELERS UPON ARRIVAL

Requirements

Filipinos	Valid Philippine Passport / Identification Certificate as proof of recognition as Filipino Citizen / Citizenship Retention and Reacquisition Act of 2003 Certificate Under RA 9225
Balikbayan	From non-visa required country under EO408 Filipinos or Former Filipino, and their spouse and children who are traveling with them, with proof of filiation
Foreign nationals with valid and existing visas	Valid visa and ACR I-Card Those holding 9(a) visa need to present an entry exemption document (EED)* from the country's foreign posts abroad

*Foreign spouses, parent/s, and/or children of Filipino citizens, not traveling with the Filipino together are exempted from securing the EED beginning Aug. 1, but must have a valid 9(a) visa with the notation "EED not required per IATF Resolution no. 128 (s. 2021)"

General Requirements

- Must not come, or must not have a travel history within the last 14 days, from countries not allowed to enter the Philippines, except Filipinos who are part of government or non-government repatriation efforts
- Must present a confirmed booking in an accredited quarantine hotel/facility per IATF-MEID Resolution 119 dated 03 June 2021 (for government and non-government repatriations), and (2) IATF-MEID Resolution No. 128-A dated 22 July 2021 (for vaccinated and non-vaccinated passengers from Green countries)
