FILIPINO CITIZENS

Except those coming, or with a travel history within the last 14 days, from countries not allowed to enter the Philippines
Subject to the presentation of required supporting documents

under EO 408, Former Filipino or traveling with

FOREIGN NATIONALS WITH VALID AND EXISTING VISAS

exemption document from the DFA/NTF]

BI GUIDE ON TRAVEL RESTRICTIONS

As of 01 June 2021

TO BE PRESENTED BY TRAVELERS UPON ARRIVAL

Requirements

Filipinos	Valid Philippine Passport / Identification Certificate as proof of recognition as Filipino Citizen / Citizenship Retention and Reacquisition Act of 2003 Certificate Under RA 9225
Balikbayan	From non-visa required country under EO408 Filipinos or Former Filipino, and their spouse and children who are traveling with them
Foreign nationals with valid and existing visas	Valid visa and ACR I-Card Those holding 9(a) visa and Special Resident Retiree's Visa (SRRV) need to present an entry exemption document from the DFA or NTF

GENERAL REQUIREMENTS

- MUST NOT COME, OR MUST NOT HAVE A TRAVEL HISTORY WITHIN THE LAST 14 DAYS, FROM COUNTRIES NOT ALLOWED TO ENTER THE PHILIPPINES
- MUST PRESENT A CONFIRMED BOOKING FOR AT LEAST TEN (10) DAYS IN AN ACCREDITED QUARANTINE HOTEL/FACILITY
